Moreover, the procedure of selecting contractors for Regional Implementation Projects is underway. Contractors who have been selected will design, supply and implement in the road distributed modules and integrate them with the KSZR Central System. In each of the regional projects, contractors are tasked to design and carry out the construction works related to the adaptation of buildings designated for regional Traffic Management Centres. The subject of the orders are also services of development as well as support and maintenance of the system.

... as well as Central Implementation Project

At the same time procedure of selecting of contractor of the key Central Implementation Project is underway. In the Central Implementation Project, the Central System will be developed along with the necessary hardware infrastructure that will control the entire system.

The National Road Traffic Management System project on the TEN-T network - stage I will cover almost one third of the roads entering Poland as part of the European TEN-T core network. In total, it is over 1,100 km. The integrated traffic management system will ensure smooth and safer driving on Polish roads.

Co-financing from EU funds

The KSZR project has received funding in the amount of over EUR 123 million from EU funds under the Connecting Europe Facility. It is run under the supervision of the European Commission through the INEA executive agency. At the national level, the supervision is conducted by the Ministry of Investment and Development and the Centre for EU Transport Projects.
